Agenda. The Regulatory Agenda serves as a planning mechanism for the agency and as a public communication of the Board's intent to review specific rules during the coming year. Upon approval, the IBHE's Regulatory Agenda will be published in the *Illinois Register* pursuant to

the Illinois Administrative Procedure Act. (5 ILCS 100)

## IBHE ADMINISTRATIVE RULES: JANUARY 2015 REGULATORY AGENDA

The January 2015 Regulatory Agenda serves as a planning mechanism for the Board and a public communication of the Board's intent to adopt new rules and review existing rules during the upcoming year. The attached Regulatory Agenda highlights the following rules to be reviewed and amended (as needed) during 2015:

- a) **Dual Credit Courses**. The Board may propose the adoption of new IBHE rules to further implement the provisions of the Dual Credit Quality Act (Public Act 96-164). The IBHE is responsible for oversight and review of dual credit programs offered jointly by high schools and institutions, except for community colleges.
- b) Performance Metrics for Budget Recommendations. Pursuant to Public Act 97-320, performance metrics designed to promote and measure student success in degree and certificate completion must be adopted by the Board by rule. The first set of metrics was developed in accordance with principles defined in the Act for the Board's FY 2013 budget recommendations for higher education. The Board intends to adopted new rules in 2015.
- c) Annual Public University Performance Report. The Board may propose the adoption of new IBHE rules to implement Public Act 97-610. Pursuant to the Act, the Board will compile and submit an annual report with information on new programs created, existing programs that have been closed or consolidated, and programs that exhibit low performance or productivity. Rules may be used to define terms and timelines for the report.
- d) Private Colleges and Universities Capital Distribution Formula (23 Ill. Adm. Code 1039). Public Act 98-674 (effective June 30, 2014) changed the grant period and Public Act 98-715 (effective July 16, 2014) added provisions to address changes in ownership between eligible grantees. The Board will review the existing rules and may propose amendments in 2015.
- e) **Higher Education Distance Learning.** Pursuant to Public Act 98-792 (effective January 1, 2015), the IBHE will propose rules for the execution of the powers and duties delegated to it by the Act, including, but not limited it, minimum standards for institutions of higher education. This Act authorizes the IBHE to participate in a state authorization reciprocity agreement (a.k.a. SARA) on behalf of Illinois and to be the lead agency in coordinating interstate reciprocity for distance learning for participating institutions in Illinois.
- f) **Grow Your Own Teacher Grants (23 Ill. Adm. Code 1085).** Public Act 98-1036 (effective January 1, 2015) amended the provisions concerning potential candidates for

the program. The Board will review the existing rules and may propose amendments in 2015.

- g) **Private Business and Vocational Schools (23 Ill. Adm. Code 1095).** The Board adopted rules in 2012 pursuant to the Private Business and Vocation Schools Act of 2012. The Board may review in 2015 and may subsequently amend the rules.
- h) **Nursing School Grant Program (23 Ill. Adm. Code 1100).** The Board adopted rules in 2006 and may review the rules in 2015 to ensure that the program continues to increase the number of nurses graduating from Illinois institutions of higher education.
- i) Nurse Educator Fellowship Program (23 Ill. Adm. Code 1105). The Board adopted rules in 2006 and may review the rules in 2015 to ensure the retention of well-qualified nursing faculty at institutions of higher learning that award degrees in nursing.
