

## Applegate's Update

### It's a Good Time to Be a College Student or Educator – Here Is Why

One of the great joys of being a part of the higher education system is experiencing the energy and sense of hope and renewal that occurs each fall as students repopulate college campuses. They are an increasingly diverse bunch in terms of age, ethnicity, and life experience. A growing number of them aren't even on the campus but are connected virtually to their college courses. Despite the dark cloud of a state budget impasse hovering above us, this week's news stories about move in days and new beginnings remind us why we are committed to higher education.

Our work to educate students grows in importance with each passing year. A recent report, "[Jobs are Back: College Graduates are First in Line](#)," shows that since the recession the U.S. economy has created nearly 3 million high paying jobs, 44 percent of all the jobs created. Of those 2.9 million high paying jobs 2.8 million were filled by people with baccalaureate degrees. Opportunities are growing. The take away message from this report is optimistic: "Students take heart, work hard, and do your part." So much for the naysayers who claim we don't need all those college graduates. However, unless college educators strive to ensure that the students now showing up for college coursework graduate with quality degrees that prepare them for these good jobs, the door to a middle class life will be slammed in their faces. IBHE is leading a statewide effort to help ensure that Illinois' higher education system is focusing on college to career success.

Through the good work of our partners in the Illinois legislature the **Commission on the Future of the Illinois Workforce** was created. It is charged with better connecting college degrees with careers in each region of Illinois. IBHE is leading the work of the Commission. With private foundation funding we are convening state leaders today to mobilize support for the Commission. Within the next year the Commission will analyze current and projected workforce needs in each region of Illinois and work with postsecondary partners to ensure the system (public, private, two-, and four-year colleges) creates partnerships with employers and fellow postsecondary schools and colleges to develop and expand the programs needed to meet those needs with the right degrees and credentials. We also will track college graduates into the workforce to measure how well we are doing in ensuring a college degree launches them into successful careers. We all know college is not just about careers but that Illinois citizens across the state regions do rely on Illinois higher education to prepare them for a middle class life in a changing 21st century economy. The hard truth is that without college level learning and credentials, too many Illinoisans are working poor, living from paycheck to paycheck. So, let's not focus solely on state budget problems but instead draw energy from our returning students and use that energy to do the things we need to do to ensure their success. Their futures depend on that success now more than at any other time. College changes everything, and college degrees can change the course of people's lives.

**The IBHE Online Complaint System is now live.** The majority of postsecondary schools, colleges, and universities in Illinois are required to provide current and prospective students with contact information for filing complaints with the IBHE and accrediting bodies. Those so required include all institutions participating in Title IV by Federal regulation, as well as all degree-granting institutions and all private business and vocational schools under IBHE authority. [Illinois Administrative Rules governing degree-granting institutions](#) and [those governing PBVS institutions](#) require authorized institutions to provide the Board's mailing address and website link for reporting complaints. The website link must be on the institution's first webpage. Institutions can now direct individuals to the [IBHE online complaint system](#), which includes step-by-step instructions and key information about the complaint process.

**Aspiring engineers** will soon be able to earn a bachelor's and a master's degree in engineering from Northern Illinois University at the main campus of Rock Valley College through a new partnership beginning in fall 2016. Students with associate's degrees in engineering science can pursue one of three bachelor's degrees – electrical or mechanical engineering, or technology in applied manufacturing – from the NIU College of Engineering & Engineering Technology on the RVC campus. Students who already have a bachelor's degree in engineering can earn a master's degree. **NIU President Doug Baker** and **Rock Valley College President Mike Mastroianni** signed a letter of intent to cement the [Rockford engineering collaboration](#) that includes critical roles for local employers and the Rockford School District. Rockford aerospace giants UTC Aerospace Systems and Woodward have pledged to establish engineering

## Increasing Affordability

**Mayor Rahm Emanuel**, University of Illinois at Chicago **Chancellor Michael Amiridis**, and City Colleges **Chancellor Cheryl Hyman** announced on August 25, a new tuition award that will enable Chicago Public Schools (CPS) graduates to pursue further education through eligibility for the [new UIC Star Scholar Award](#), a UIC-funded education award, for two years. This new program will allow at least 250 Star Scholars who transfer from CCC to UIC with an Associate Degree and a 3.0 GPA, to receive an Award of \$5,000 over two years two years support to access a bachelor's degree from the University of Illinois at Chicago following graduation from City Colleges.

The Illinois Legislative Latino Caucus Foundation will soon grant **approximately twenty-five \$2,000 scholarships** to deserving full-time undergraduate college students who are residents of Illinois and of Latino ancestry.
