AAT Implementation Survey Results

A Report

Overview

Since September 2002, four Associate of Arts in Teaching degrees have been approved and endorsed respectively by the Illinois Community College Board and the Illinois Board of Higher Education in Secondary Science, Secondary Math, Special Education and Early Childhood. Upon receiving the Boards' endorsements, community colleges across the state immediately began developing program proposals for approval of these new degrees and, in turn, initiated recruitment of students into these programs.

With students entering the community college teacher pipeline, Illinois will begin seeing AAT graduates within the next two years. This has raised questions on how prepared universities are to support students who have earned an AAT degree and qualify for acceptance into teacher preparation programs. What policies and practices regarding transfer admissions protocol have been instituted to inform students, advisors, admissions and transfer staff?

The AAT Steering Committee, at its January 26th meeting addressed these concerns and moved to develop an AAT Implementation Survey that would gauge levels of degree acceptance, policy development, designated contact personnel, and course/standards documentation at four-year colleges and universities. On February 20th the Illinois Board of Higher Education emailed the AAT Implementation Survey to the presidents of all public and private institutions with undergraduate teacher preparation programs. Provosts and Deans of Education were cc'd on the email correspondence.

Content of Survey

The survey posed the following questions.

- 1. Acceptance of AAT degrees:
 - Will your institution accept the Associate of Arts in Teaching?
 - If so, which AAT degrees will be accepted?
- 2. Policy:
 - a. What policies have been established to facilitate transfer for students who complete an AAT degree?
 - b. Please provide the text included in your catalog, transfer pages, etc. regarding acceptance of the AAT degrees.
 - c. If your institution does not currently have a policy on acceptance, but is in the process of establishing a policy, please give an approximate date for initiation of the policy.

3. Contact Person:

The individual at your institution whom advisors and students should contact for information on your acceptance of the AAT.

4. Courses/Standards:

Document the courses and standards a student would be required to fulfill at your institution in order to complete a baccalaureate degree after transferring with the AAT. Please be as specific as possible. Understandably, your response might not include every permutation but should address the courses/standards that students with the AAT would most likely need to complete. Please align the course(s) with the standard(s) where applicable.

5. Information:

Attach any literature your institution has developed to inform students and stakeholders about the AAT degrees.

Survey responses

Fifty-two of the fifty-seven approved teacher preparation programs in Illinois have programs to which AAT degree holders can transfer. Of these a total of thirty-eight (73%) institutions responded to the survey--11 public universities (92%) and 27 (68%) private colleges/universities.

	At the present time, only one two-year institution, Truman College, has contacted us regarding developing an AAT. I directed them to the program chairs for math and chemistry, to work out the details for coursework in the degree, but no further action was taken. I have talked to the math program chair, who may be amenable to acceptance of an AAT degree if the math prerequisites are agreed upon. At the present time, we generally accept credits from two-year institutions for introduction to education coursework, but this is done on a case-by-case basis. In addition, the College of Liberal Arts and Sciences follows the articulation agreements in place for accepting general education credits from two-year institutions. Kimberly Clark, Associate Director for Secondary Education in the College of Liberal Arts and Sciences Student Affairs Office reports that she has not been approached by any student desiring to be a teaching major who has an AAT degree.

UIC	I've listed all of the coursework required to become certified in mathematics, chemistry, and physics for teacher education majors. I could envision that an AAT degree would include our introductory education courses (ED 200/ED 210) and general education requirements. For math , it is feasible that students could have taken Calculus I & II, but no articulation agreement exists. Calculus I & II and Math 210, chem. 112, and chem. 114 are required as prerequisites for physics and for chemistry , Calculus I, II, and III, General Physics I and II or Introductory Physics 1 and II are prerequisites. These are in addition to other general education requirements in English, foreign language, humanities, etc.
