#### 11:00 a.m. Session II: Supporting Students' Learning Renewal and Academic Success: Rethinking Developmental Education

In Illinois and nationally, African American and Latinx students are placed in non-credit, developmental education courses at rates higher than white students. Students in developmental education spend time and money to improve their skills in subjects such as Math and English. This delays their ability to enroll in credit-bearing coursework and, for those who persist, extends their time to degree. The Illinois Board of Higher Education and the Illinois Community College Board are working with academic leaders and faculty to implement effective alternatives to traditional developmental education models. This session will feature the work of three public universities to support students' learning recovery and academic success in the COVID era.
