## IAI Legislation



## The Illinois Articulation Initiative Act (110 ILCS 152/1)

The General Assembly finds and declares that in January of 1993, the Board of Higher Education, the Illinois Community College Board, and transfer coordinators from Illinois colleges and universities jointly launched the Illinois Articulation Initiative to ease the transfer of students among Illinois public and independent associate and baccalaureate degreegranting institutions. The General Assembly finds and declares that the Illinois Articulation Initiative was driven by the following foundational ideas:

- that associate and baccalaureate degree-granting institutions are equal partners in educating college freshmen and sophomores.
- that faculties should take primary responsibility for developing and maintaining program and course articulation: and
- that institutions are expected to work together to facilitate transfer for lower-division baccalaureate programs.

The General Assembly finds and declares that students have benefited by receiving the General Education Core Curriculum and transferring across institutions of higher education. urce P.A. 99-636, eff. 1-1-17).

## IAI: Celebrating 25 years of full implementation!

#### Today, there are 108 institutions participating in IAI:

• <u>75 Full Participants</u> maintain a complete IAI GECC package of courses and agree to accept a completed GECC package from any other participating institutions as meeting all lower-division general education requirements.

• 33 Receiving-Only Participants agree to accept a completed GECC package from any other participating institution as meeting all lower-division general education requirements of the

institution.

# 2023 – Amendments to IAI Legislation How do these changes impact the work of the Review Panels?



## IAI Amendments to Section 15 Participation

#### **Existing**

All public institutions shall maintain a complete Illinois Articulation Initiative General Education Core Curriculum package, and all public institutions shall maintain up to 4 core courses in an Illinois Articulation Initiative major, provided the public institution has equivalent majors and courses.



## IAI Amendments to Section 15 — Participation

#### Revised

### Impact on Institution

All public institutions shall maintain a complete Illinois Articulation Initiative General Education Core Curriculum package, and all public institutions shall **submit and** maintain up to 4 core courses in each of the an Illinois Articulation Initiative majors major, provided the public institution has equivalent majors and courses.

An institution must be recognized as a participant of IAI, either as a full participant (both receiving and transferring institution) or as a receiving only institution. As a participant in the Illinois Articulation Initiative, course syllabi are submitted to one of the General Education Core Curriculum or Major Panels for equivalency review aligned to criteria established by the discipline's panel. Once approved, the course will carry the IAI designated code. The institution must submit the course for ongoing review approximately every five years after the initial approval date.



## IAI Amendments to Section 15 Participation Questions

Does my institution have to submit and maintain a course for ALL major panels?

**YES** – if your institution has equivalent majors and courses for a major panel, your institution should have at least one, but no more than four courses submitted and approved for each panel. A good example of an exception to this requirement is the major panel for Agriculture. Not all institutions have agriculture as a major and/or equivalent courses in this area; therefore, the institution would not be required to submit a course to this major panel.



## IAI Amendments to Section 20 **Course Transferability**

#### **Existing**

(a-5) All public institutions shall determine if Illinois Articulation Initiative major courses are direct course equivalents or are elective credit toward the requirements of the major. If the receiving institution does not offer the course or does not offer it at the lower-division level, the student shall receive elective lower-division major credit toward the requirements of the major for the course and may be required to take the course at the upper-division level.



## IAI Amendments to Section 20 **Course Transferability**

#### Revised

#### Impact on Institution

(a-5) All public <u>institutions'</u> institutions shall determine if Illinois Articulation Initiative major courses **must be transferable as** are direct course equivalents or are elective credit toward the requirements of the major. If the receiving institution does not offer the course or does not offer it at the lower-division level, the student shall receive elective lower-division major credit toward the requirements of the major for the course and may be required to take the course at the upper-division level.

This change clarified the concept of direct transfer equivalent. What this means is, if a course has earned an IAI major code from a two-year institution and the fouryear baccalaureate granting institution they are transferring into also has a course designated with the same IAI code, the four-year institution must accept this course as a major course.

- If you do not have your Organic CHEM I and Organic CHEM II courses approved as IAI, you must accept those two courses in as MAJOR Elective courses.

## Chemistry/CHM - IAI Major **Course Recommendations**

Bachelor's programs in chemistry are built on an in-depth foundation of some institutions offer a specialty in biochemistry or certification for high school teaching. To transfer as a junior into a bachelor's chemistry program, students must complete a minimum of 60-semester credits, including all of the essential prerequisite courses below. Students should

be aware that because of differences among schools in the number of credits for which various courses are offered and the possible need for prerequisite courses, it may be difficult to complete an Associate in Science degree without taking more credits than can be accepted in transfer. Students planning on a chemistry major

A grade of C or better may be required for chemistry, mathematics, and engineering science courses to transfer.

Chemistry IAI GECC Recommendations

(Minimum 37 semester credits)

These are the specific courses in the Illinois Transferable General Education Core Curriculum (IAI GECC) that should be taken for this emphasis.

**Communication:** 3 courses (9 semester credits)

Select a two-course sequence in writing (6 semester credits) with a grade of "C" or better and, Select 1 course in oral communication (3 semester credits).

Mathematics: 1 course (3 semester credits)

Select from Mathematics - Calculus I & II.

Physical and Life Sciences: 2-3 courses (8-10 semester credits)

Select Calculus based Physics I with labs

Select Calculus based Physics II with labs

Students should take the first course in the **BIO 910 sequence/L1910L** which will fulfill the life sciences requirement.

Humanities and Fine Arts: 3 courses (0-9 semester credits)

Select 1 course from Humanities,

Select 1 course from Fine Arts and

Select 1 from either Humanities or Fine Arts. - Courses can be taken from the same identifier as long as the course outcomes are different.

Social and Behavioral Sciences: 3 courses (9 semester credits)

Select 3 courses from at least 2 different disciplines (e.g., no more than 2 courses from, for example, psychology). - Courses can be taken from the same identifier as long as the course outcomes are different.

The worksheet allows you to see what courses to take to fulfill the IAI Gen. Ed. package (Illinois Transferable
General Education Core Curriculum) at any participating college or university in the State. You will find it helpful
to use the major recommended general education courses shown above. You may want to print or copy a hard
copy of this page.

- IAI provides recommended pathway to complete the GECC package and the CORE Courses for a future Chemistry Major while at the Community College.
- Legislative Amendment provides an opportunity to evaluate how you accept those core courses.
- This may be an opportunity to evaluate course offerings. Can your courses be offered at the 200 level or be submitted for IAI approval still at the 300 level?
- These actions provide students opportunities to take more upper-level elective courses in their major and eliminate need to duplicate coursework.

## IAI Amendments to Section 25 **IBHE and ICCB Duties**

#### **Existing**

(a) The Board of Higher Education and the Illinois Community College Board shall co-manage the implementation, oversight, and evaluation of the Illinois Articulation Initiative, including determining when panels must be discontinued or convened and the specific requirements of the General Education Core Curriculum. ## IAI Amendments to Section 25 **IBHE and ICCB Duties**

#### Revised

(a) The Board of Higher Education and the Illinois Community College Board shall co-manage the implementation, oversight, and evaluation of the Illinois Articulation Initiative, including determining when panels must be discontinued or convened and the specific requirements of the General Education Core Curriculum. Panels must be convened across the fields of General Education, Communications, Humanities and Fine Arts, Life Sciences, Physical Sciences, Social and Behavioral Sciences, Mathematics, Elementary and Secondary Education, and other fields as determined by the Board of Higher Education and the Illinois Community College Board.

#### Impact on Institution

The amended legislation included provision for major panel focus on Elementary and Secondary Education.



## IAI Major Panels

The IAI Major Panels were developed to assist students who know their major but are undecided about their transfer-to institution.

Just as with the IAI GECC panels, the Major Panel members develop common understandings about the lower-division objectives and curriculum content in the discipline and monitor changes and developments in the discipline that may affect a student's preparation for upper-division work.

For the undecided students, each Major Panel has identified 1 to 4 core courses that are commonly required of all students in that major which are typically taken at the lower-division level.

What do these amendments mean to faculty and staff currently serving on an IAI panel?

There is no change in the way in which the <u>panels</u> operate. They will continue to review courses using the established criteria and will continue to improve upon communication to institutions to help them in the preparation of syllabi for IAI approval. [8 faculty members, 1 Transfer Coordinator, 1 Dean/ Deans Rep; co-chairs are voted on by panelists – typically one is from IBHE institutions, other is from an ICCB institution.

#### So – what exactly is that work?

- Requires an understanding of:
  - How syllabi are built
  - Agreed upon content typically covered in a course for a given description
  - An understanding of the relationship between course outcomes, course topical





## **Key Takeaways**

- IAI is a legislative initiative higher education, by law, is expected to be an active participant.
- Transferability Major courses receiving IAI code are considered as direct transfer equivalents into the major.
- Faculty reviewers are expected to be knowledgeable on syllabus creation, core components, and relationship between outcomes, assessments, and course topical outlines.
- Transfer Coordinators understand how the courses are used across different majors
- Deans / Deans Reps provide context with how the course fits within the discipline can articulate future vision for the discipline within their institutions (e.g., CJUS).
- Take time to familiarize yourself with IAI site use resources linked in the presentation.
