STATE OF ILLINOIS BOARD OF HIGHER EDUCATION

IBHE ADMINISTRATIVE RULES: JANUARY 2018 REGULATORY AGENDA

The January 2018 Regulatory Agenda serves as a planning mechanism for the Illinois Board of Higher Education (IBHE or Board) and a public communication of the Board's intent to adopt new rules and review existing rules during the upcoming year. The attached Regulatory Agenda highlights the following rules to be reviewed and amended (as needed) during 2018:

- a) Diversifying Higher Education Faculty in Illinois Program (23 Ill. Adm. Code 1080). The Board first adopted rules in 2006 and may review the rules in 2018 to ensure the program continues to encourage minority students to enroll and complete academic programs at the post-baccalaureate level and to enhance the diversity of faculty and professional staff at the Illinois higher education institutions and agencies.
- b) Data Collection, Security and Confidentiality, Sharing and Fees (23 Ill. Adm. Code 910). Pursuant to Public Act 100-417, the IBHE may set fees to cover the cost of processing and handling individual student-level data requests pursuant to an approved data sharing agreement. The Board intends to adopt new rules in 2018.
- c) Postsecondary and Workforce Readiness Act (23 Ill. Adm. Code 1034). Pursuant to Public Act 99-674, the IBHE may adopt such administrative rules as may be necessary to create statewide panels and to support instruction in transitional mathematics and in reading and communication transitional competencies. Implementation is subject to the availability of public or private resources for its administration. The Board may promulgate rules in 2018.
- d) Performance Metrics for Budget Recommendations (23 III. Adm. Code 900). Pursuant to Public Act 97-320, performance metrics designed to promote and measure student success in degree and certificate completion must be adopted by the Board by rule. The first set of metrics was developed in accordance with principles defined in the Public Act for the Board's Fiscal Year 2013 budget recommendations for higher education. The Board intends to adopt new rules in 2018.
- e) **Grow Your Own Teacher Grants (23 Ill. Adm. Code 1085).** The Board may review the existing rules and amend the rules in 2018.
- f) Nursing School Grant Program (23 Ill. Adm. Code 1100). The Board amended the rules in 2011 and may review the rules in 2018 to ensure that the program continues to increase the number of nurses graduating from Illinois institutions of higher education.
- g) Nurse Educator Fellowship Program (23 Ill. Adm. Code 1105). The Board adopted rules in 2006 and may review the rules in 2018 to ensure the retention of well-qualified nursing faculty.
