EXECUTIVE SESSION MINUTES AND VERBATIM RECORDINGS

Submitted for: Action.

Summary: This item recommends that the Illinois Board of Higher Education maintain the confidentiality of the minutes from its Executive Sessions held June 2, 2015, February 5, 2017, February 6, 2017 and March 14, 2017.

This item further recommends that the destruction of verbatim recordings that exist for the Executive Sessions held February 3, 2015, April 6, 2015, June 2, 2015, August 11, 2015 and October 6, 2015, be approved in accordance with Section 2.06(c) of the Open Meetings Act pursuant to the recommendation of Outside Counsel.

Action Requested: That the Illinois Board of Higher Education determines that the minutes of the Executive Sessions on June 2, 2015, February 5, 2017, February 6, 2017 and March 14, 2017 continue to remain confidential.

That the destruction of any verbatim recordings for the Executive Sessions held February 3, 2015, April 6, 2015, June 2, 2015, August 11, 2015 and October 6, 2015, be approved in accordance with Section 2.06(c) of the Open Meetings Act pursuant to the recommendation of Outside Counsel.

EXECUTIVE SESSION MINUTES AND VERBATIM RECORDINGS

The Illinois Open Meetings Act (5ILCS 120 et seq.) requires that minutes of all closed meetings (Executive Sessions) of public bodies which have not been made available to the public be reviewed periodically to determine whether those minutes should continue to remain confidential.

Based upon the recommendation of Outside Counsel, the Illinois Board of Higher Education (IBHE) previously determined that the minutes of the IBHE Executive Sessions of June 2, 2015, February 5, 2017, February 6, 2017 and March 14, 2017 should remain confidential. Upon review, it has been suggested that need for confidentiality still exists for each of these meetings.

Also, pursuant to Section 2.06 of the Open Meetings Act, the IBHE has the right to destroy the verbatim records of Executive Sessions that occurred 18 months or more prior to such authorization provided that the IBHE has approved the destruction of the recordings and further approved minutes of the subject closed sessions that meet the requirements of Section 2.06(a) of the Open Meetings Act. It is recommended that the destruction of verbatim recordings that exist for any Executive Session held February 3, 2015, April 6, 2015, June 2, 2015, August 11, 2015 and October 6, 2015, be approved in accordance with Section 2.06(c) of the Open Meetings Act pursuant to the recommendation of Outside Counsel.

The adoption of the following resolutions is recommended:

The Illinois Board of Higher Education hereby resolves:

Resolved, that the Illinois Board of Higher Education finds that the need for confidentiality exists for the minutes of the IBHE Executive Sessions of June 2, 2015, February 5, 2017, February 6, 2017 and March 14, 2017, and that such minutes shall continue to remain confidential; and further

Resolved that the destruction of verbatim recordings for Executive Sessions held February 3, 2015, April 6, 2015, June 2, 2015, August 11, 2015 and October 6, 2015, be approved in accordance with Section 2.06(c) of the Open Meetings Act pursuant to the recommendation of Outside Counsel.
