Summary:

EXECUTIVE SESSION MINUTES AND VERBATIM RECORDINGS

The Illinois Open Meetings Act (5 ILCS 120 et seq.) requires that minutes of all closed meetings (Executive Sessions) of public bodies which have not been made available to the public be reviewed periodically to determine whether those minutes should continue to remain confidential.

Based upon the recommendation of Outside Counsel, the Illinois Board of Higher Education (IBHE) previously determined that the minutes of the IBHE Executive Sessions of J September 23, 2019 Executive Committee and November 22, 2019 Executive Committee should remain confidential. Upon review, it has been suggested that need for confidentiality still exists for each of these meetings. Further, based on the recommendation of Outside Counsel, that the following listed Executive Session minutes, all of which have been previously approved by the Board, be opened for review as the need for confidentiality no longer exists: June 5, 2018, August 2, 2018, September 10, 2018 and December 4, 2018.

Also, pursuant to Section 2.06 of the Open Meetings Act, the IBHE has the right to destroy the verbatim records of Executive Sessions that occurred 18 months or more prior to such authorization provided that the IBHE has approved the destruction of the recordings and further approved minutes of the subject closed sessions that meet the requirements of Section 2.06(a) of the Open Meetings Act. It is recommended that the destruction of verbatim recording that exists for any Executive Session held June 5, 2018, be approved in accordance with Section 2.06(c) of the Open Meetings Act pursuant to the recommendation of Outside Counsel.
