IBHE ADMINISTRATIVE RULES: JANUARY 2021 REGULATORY AGENDA

The January 2021 Regulatory Agenda serves as a planning mechanism for the Board and a public communication of the Board's intent to adopt new rules and review existing rules during the upcoming year. The attached Regulatory Agenda highlights the following rules that may be reviewed and amended during 2021:

- a) Independent Colleges Capital Investment Grant Program (23 III. Adm. Code). The Board, jointly with the Capital Development Board, will promulgate rules in 2021 to implement this grant program, pursuant to Public Act 101-604. This program is similar to the rules adopted by the Board for the Independent Colleges Capital Program.
- b) Diversifying Higher Education Faculty in Illinois Program (23 III. Adm. Code 1080). The Board will review this rule since Public Act 101-354 reduced the number of Program Board members from 21 to 11. Findings of the review may result in proposed amendments in 2021.
- c) **Higher Education Distance Learning Act (23 III. Adm. Code 1033).** The Board may review this rule for potential revisions due to changes in the National Council for State Authorization Reciprocity Agreements (NC-SARA) policies for states. Findings of the review may result in proposed amendments in 2021.
- d) **Dual Credit Courses (23 III. Adm. Code 1009).** The Board may review this rule in 2021. Findings of the review may result in proposed amendments.
- e) Approval of New Units of Instruction, Research, and Public Service at Public Institutions (23 III. Adm. Code 1050). The Board may review this rule in 2021. Findings of the review may result in proposed amendments.
- f) Program Review Private Colleges and Universities (23 III. Adm. Code 1030). The Board may review this rule in 2021. Findings of the review may result in proposed amendments.
- g) **Private Business and Vocational Schools (23 III. Adm. Code 1095).** The Board may review this rule in 2021. Findings of the review may result in proposed amendments.
- h) Performance Metrics for Budget Recommendations (23 III. Adm. Code 900). Pursuant to Public Act 97-320, performance metrics designed to promote and measure student success in degree and certificate completion must be adopted by the Board by rule. The first set of metrics was developed in accordance with principles defined in the Public Act



for the Board's Fiscal Year 2013 budget recommendations for higher education. The Board may adopt new rules in 2021.
