## WHAT IS THE PAC

- Proprietary Advisory Committee

      - Private Corporations or LLC
      - Authorized to operate in IL
      - Board approval of one or more degree-granting programs
- Meet Quarterly with IBHE representation
- Chair, Vice-Chair, and Secretary

#### **Student Focus**

- Emphasized equity
- Moved to online/remote courses in Spring
- Used student feedback to modify and adjust
- Provided training for students to use online tools
- Expanded online learning and simulation capabilities
  - Anatomy & Physiology technologies, Medical scanning for imaging
  - Nursing
  - Radiography
- Offered delayed or flexible payment plans for tuition and fees, if not covered by financial aid, including certification exams

## **Limiting Interruptions**

- Continue to offer courses that students needed to graduate
- Shift to simulations for lab and clinical experiences when possible
- Partner with accreditation to adjust requirements to allow for waivers

#### **Resource Focus**

- Assisted students to find and retrieve necessary resources
- Provided internet access (hot spots)
- Provided computers
- Made additional investments in IT infrastructure to support remote learning
  - Help Desk resources, telecommunication/online meetings technologies
- Expanded capabilities of LMS
  - To include video component, greater security, online proctoring, etc.
  - Procured LMS if one wasn't in place

### **Transitioning Quickly**

- Adjusted to online to continue Spring Quarter/Semester
  - Online final exams
- Continued to adjust to offer Summer courses
- Modified requirements at the last minute to continue to remain compliant

#### **Supporting Each Other**

- Met to discuss
- Shared best practices
- Provided resources to others
  - DeVry offered webinars
