## EXECUTIVE COMMITTEE OCTOBER 24, 2022

An Executive Committee meeting of the Illinois Board of Higher Education ("IBHE" or "Board") was convened at 10 a.m. and conducted via WebEx as permitted by Public Act 101-0640 enacted June 12, 2020. Chair John Atkinson determined that a fully in-person meeting is not practical nor prudent due to the disaster.

The following Board members were present: John Atkinson, Chair, Jennifer Delaney, Veronica Herrero, and Pranav Kothari.

The following Board member was absent: Jennifer Garrison.

The meeting was conducted by video conference as allowed by Public Act 101-0640 and roll call votes were recorded for each matter acted upon. Audio of the meeting was recorded and may be requested on the IBHE website.

## A. Call to Order/Roll Call

Chair John Atkinson called the meeting to order. Board Secretary Rembusch took roll call. A quorum was present.

Executive Director Ginger Ostro provided the background and information on the Capital Investment Grant Program for Independent Colleges. She stated that the program is for independent colleges and universities to access capital dollars for their facilities. The State Capital Development Board has an appropriation of \$400 million for the grant program. Ms. Ostro explained how the grant applications will be evaluated and how the strategic plan equity plan will be included in the review.

Ms. Ostro explained that the rules for the program had gone through the full Joint Committee on Administrative Rules (JCAR) process and that no public comment had been received and no changes had been requested by JCAR\*. Therefore, the rules are being presented to the Board for a second approval, as required.
