A Board Retreat Meeting of the Illinois Board of Higher Education was held in person at the University of Illinois, Chicago, 828 South Wolcott, Chicago, Illinois and via videoconference as permitted by the Illinois Open Meetings Act (5 ILCS 120/7). The meeting was recorded and an announcement to that effect was made by the Chair at the beginning of the meeting.

A. Call to Order/Roll Call

Call Meeting to Order, Pranav Kothari

Chair Pranav Kothari called the meeting to order at 1:05 p.m. Acting Board Secretary Kelm took roll call. A quorum was present.

A motion was made by Board Member Herrero and seconded by Board Member Delaney to allow Board Member Shaw to participate via videoconference. A roll call was taken, and the Motion was approved.

Opening Remarks by Chairman Kothari:

Chair Kothari opened the retreat with some housekeeping comments regarding the Open Meetings Act and public participation.

The Chair outlined the goals for the Retreat to include:

- Refresh the Board on A Thriving Illinois and introduce the strategic plan to new Board members;
- Update the Board on Work Underway;



- Align the Board around next phase of work: strategies to expand/deepen or new strategies to launch; and
- Refine Board engagement/approach to meetings.

Executive Director Ostro and Chief of Staff Minor:

CoS Minor facilitated a brief "ice breaker" activity.

ED Ostro, joined by Illinois Community College Board Executive Director Brian Durham provided the Board with an overview of the Strategic Plan. Discussion ensued regarding strategies and what success may look like.

Chair Kothari led a discussion related to the priorities for the next three years. Specifically, a focus on "accountability" was discussed as well as expanding paths to transfer. A Board committee focused on accountability was considered.

Chair Kothari continued with a discussion involving Board meeting structure and engagement. Members discussed their experiences on other boards and how IBHE Board meetings could be better managed.
