### **MAP Matters**

The House Higher Education Appropriations Committee received testimony from IBHE Chair Tom Cross and ISAC Executive Director Eric Zarnikow on March 16 related to the fiscal year 2018 budget proposals. Both Cross and Zarnikow returned to the General Assembly to testify before the Senate Appropriations II Committee on March 30, again on budget proposals for 2018, and both discussed the Monetary Award Program (MAP) and its benefits to Illinois higher education.


The Monetary Award Program (MAP) recommendations for FY18, include the governor's budget recommendation increasing funding to \$401 million, \$36.5 million more than appropriated for FY15, which would allow the program to serve more than 12,000 additional students. The IBHE recommended an even bigger investment in MAP for FY18, requesting an additional \$100 million. This could serve an additional 33,000 to 40,000 students at the current level of awards or increase the amount of the student awards to help keep pace with tuition and fee increases. For FY16, funding for the second half of the 2015-16 school year was not appropriated until the end of June, after the school year had ended. To date, NO funding has yet been approved to pay for FY17 MAP grants for this current school year.



Chair Cross brought attention to the fact that even if MAP were to receive these additional appropriations, it would still be underfunded. Over the last decade, demand has increasingly exceeded funding, so much so that in the last few years, the state has only been able to offer MAP grants to less than half the students who are eligible. About 150,000 students each year have been turned away. The dollar amount of funding for MAP has been relatively flat since 2002 while the volume of eligible students has increased by over 100,000, a 50% increase. It is estimated that a total of \$944.2 million would be needed in order to cover all MAP eligible students under the current formula. With the ongoing delay in funding MAP, Illinois colleges and universities are seeing more and more MAPeligible students making the choice to go part-time, out-ofstate, or simply not to attend college at all. "It is a mistake for us as a state not to be committed to continue with MAP grants

to make sure Illinoisans that want to go to college but don't have the financial means can go," Cross stated. "We should help them to get on the college track, and that is what MAP can do."

ISAC Director Zarnikow's testimony focused on the crucial role MAP plays in providing access to college, including evidence that MAP gets results. MAP recipients graduate at about the same rate as other students at the same college despite facing far more financial obstacles than their peers. In part because of the success of MAP, Illinois has the second highest public university graduation rate in the region, at 59%, despite educating more lower-income students than other states in the region. Moreover, MAP recipients regularly share that the program is vital for their success. From a recent ISAC survey of recipients: MAP played an important role in helping them enroll in college, reduced the number of hours they had to work, and reduced the amount of money they had to borrow. MAP is vital in helping minorities go to college – almost 60% of black students and over 40% of Hispanic students at Illinois public universities attend college with the help of MAP. The average family income of a MAP recipient is about \$28,000 and about 55% have no resources to pay for college. A majority of MAP recipients come from a home where no parent has a college credential. MAP recipients often choose service majors: health, business and education majors are the most popular.

"Notably, MAP has long had bipartisan support and has received at least level funding in nearly every proposed budget bill. Indeed, the governor and legislators in both chambers have indicated that they are still interested in providing "an appropriate level of support" for MAP in fiscal year 2017, as well as additional funding for next year," stated Zarnikow. "The delay is particularly frustrating because our elected officials appear to agree that MAP funding is needed to provide access for hundreds of thousands of Illinoisans with modest means who want to attend college, and for the Illinois community colleges, public universities and private colleges and universities who want to provide a college education to them."

Education Management Corporation (EDMC) has announced the execution of a definitive agreement for the sale of substantially all the assets of EDMC and its schools to **Dream**Center Foundation (DCF), a not-for-profit foundation. The sale is expected to be completed in summer of 2017.

The transaction includes all the faculty and staff of **Argosy University** and the **Art Institutes of Chicago and Schaumburg**, which are currently enrolling new students. It also includes a majority of the employees from EDMC's corporate offices. Students currently enrolled at the education systems will continue in their studies.

The Dream Center Foundation is an endowment fund that provides opportunity and resources to many people in the United States through its 110 locations across the country. The transaction provides the various schools the opportunity to educate students as part of a not-for-profit organization. The transaction is subject to a number of operational and other closing conditions, including the receipt of regulatory approvals from the U.S. Department of Education, institutional accrediting agencies, state licensing boards, programmatic accreditation bodies, and IBHE.

Two freshman engineering students from the University of Illinois at Urbana-Champaign, Alex Darragh and Matt Steinlauf, have been selected as one of seven teams from across the world (from among an applicant pool of over 3,000) to have their experimental design to support life on the moon carried into space by **Team Indus**. Team Indus is a part of the Google Lunar Xprize challenge to develop low-cost methods of robotic space exploration. Governor Bruce Rauner announced he has appointed Don Edwards to the University of Illinois Board of Trustees. Currently, Edwards is the CEO of private equity investment firm Flexpoint Ford (Edwards Capital LLC). He also serves on the boards of the Chicago Park District, World Business Chicago, the Museum of Contemporary Art, and Lurie Children's Hospital. Edwards earned his bachelor's degree from the University of Illinois and his MBA from Harvard Business School. He lives in Chicago.

Dr. Dennis Papini has been selected to become the provost and vice chancellor for academic affairs of the University of Illinois Springfield (UIS). Papini has served as dean of the College of Arts

and Sciences at South Dakota State University since 2012. In that role he oversaw 15 academic departs, helped create a new strategic plan, added four new degree programs, helped fundraise \$86 million, and launched an Underrepresented Dissertation Fellows Program to bring minority faculty to the university. "Dr. Papini received strong support from the Provost search committee, whose members were appreciative of the depth and breadth of his experience as it relates to the Provost position as well as his strong listening skills, budgeting background, and results-oriented planning experience," **UIS Chancellor Susan J. Koch**.

A native of Orion, IL, Papini earned his bachelor's degree from Western Illinois University and holds a Ph.D. and master's degree from West Virginia University.





Chicago Mayor Rahm Emanuel has announced Juan Salgado to serve as the next Chancellor of City Colleges of Chicago (CCC). Salgado has focused his 20-year career on improving education and economic opportunities for residents in low-income communities. Salgado also brings to the role experience working with CCC, which he has partnered with since 2005 to address the needs of bilingual students and professionals by advocating for stronger career pathways in healthcare fields. Salgado has served as CEO of Instituto del Progreso Latino since 2001, where he is focused on empowering residents through education and skill-building programs that lead to sustainable employment and economic stability.

"I am honored that Mayor Emanuel has given me the opportunity to lead and build on the momentum City Colleges has gained in recent years," said Salgado. Salgado is originally from Calumet Park, and he began his college education at Moraine Valley Community College, moving on to earn a Bachelors from Illinois Wesleyan, and a Masters from the University of Illinois at Urbana-Champaign. Salgado has been lauded nationally for his work, most recently as a 2015 recipient of the "MacArthur Genius" award, one of the most prestigious innovation prizes in the United States.

Southern Illinois University Edwardsville's Kim Durr, chief of staff in the Office of the Chancellor, has been appointed chair of the National Association of Presidential Assistants in Higher Education (NAPAHE) organization's Board of Directors. Durr assumed the one-year post at NAPAHE's annual meeting on March 12 in Washington, D.C. The mission of NAPAHE is to enhance the profession of its nearly 500 members and "address the broad range of roles fulfilled by presidential assistants in service to presidential leadership and higher education."



Rockford University President Eric W. Fulcomer has announced the appointment of Dr. Michael P. Mihalyo, Jr. as Provost and Vice President of Academic Affairs, effective this summer. Dr.



Mihalyo will succeed **Dr. Belinda Wholeben**, who will retire after 23 years with the University at the end of the academic year, serving the last two years as provost. Mihalyo has more than two decades of experience in higher education, and previously has filled the role of provost at two liberal arts colleges in West Virginia: Bethany College and Davis and Elkins College, where he was appointed president. Most recently, he served as president of the Kentucky-based Appalachian College Association.

#### **Other News**

The **US Department of Homeland Security**, National Protection & Programs Directorate, Infrastructure Security Compliance Division (DHS, NPPD, ISCD) works to ensure facilities holding certain Chemicals of Interest (COI) are properly securing them under the Chemical Facilities Anti-Terrorism Standards (CFATS) program, established under 6 C.F.R. Part 27. The intent of the CFATS program is to identify and regulate high-risk chemical facilities to ensure they have security measures in place to reduce the risks associated with these chemicals and to protect chemical facilities from the threat of terrorist attack or exploitation.

Since CFATS is a relatively new regulation, some facilities/organizations are not aware of the regulation and their requirements under the law, resulting in the issue of noncompliance with the CFATS program.
