IBHE is seeking an **Assistant Director of Data and Accountability Systems** to provide expertise as the Board implements its strategic plan, builds out an accountability system, and makes better use of its longitudinal data system.

Primary Responsibilities

Joining the Information Management and Research team, this position is responsible for helping build and support IBHE's accountability system, data-informed decision making, and actionable analysis and recommendations.

Major Duties and Responsibilities:

- Supports the development of a new higher education accountability system that reinforces and measures progress toward Equity, Sustainability, and Growth, as outlined in A *Thriving Illinois*.
- Develops and conducts analysis using new data from the public universities' adoption of the Common App.
- Conducts equity-centered analysis on application, enrollment, persistence, and completion of students.
- Builds and communicates data insights to decision-makers and other stakeholders through a variety of data visualization, reports, presentations, and other information tools.

- is passionate about public service and education
- is a doer, a good communicator, and intellectually curious
- is committed to continuous learning and growing
- is a supportive colleague, reinforcing a strong team-focused culture

Education and Experience:

- Bachelor's degree in one of the social sciences, education, math, statistics, or an IT-related field. Master's preferred.
- Minimum of one year of combined experience (including internships) as an analyst, report developer, data modeler, or other data analysis related role.
- Experience in the design, development, and implementation of streamlined or automated reporting solutions a plus.
- Experience (including internships) using one or more common analytical (R, SAS, SPSS, Stata), querying (SQL), and/or visualization (Tableau, Power BI) tools

- Ability to conceptualize and bring a project to fruition
- Strong problem-solving and troubleshooting skills
- Strong oral and written communications and the ability to present data and analysis to non-technical and non-research staff

- Excellent interpersonal skills, with a strong focus on collaboration and teamwork

Work Location:

Work locations are Chicago, IL with a fully remote schedule and Springfield, IL, with a hybrid work schedule. Those located in other areas of Illinois will also be considered. Occasional travel within Illinois is expected, as required by the work.
