The Position: Associate Director of Workforce Analytics

IBHE is working to ensure that Illinois higher education continues to be a leader in developing a diverse talent pipeline that will drive Illinois' economic growth. As part of the strategies in A *Thriving Illinois*, we are undertaking a new portfolio of work, in partnership with other state agencies, to assess the current and future regional and statewide employment needs, to identify the portfolio of academic programs offered throughout the state, and to determine where gaps and/or mismatch might exist.

The Associate Director, as the founder of this role and work, will be responsible for conceptualizing the project, building a methodology and conducting an annual analysis on this and in other areas that will inform Board decision-making.

Primary Responsibilities

The Associate Director provides leadership, oversight, and thought partnership to IBHE's growing role in actively fostering the state's economic growth through higher education policy.

- Develops and implements a methodology for an annual statewide supply and demand analysis, assessing regional and statewide economic needs, the state's portfolio of academic programs, and determining gaps or mismatch.
- Analyzes earnings and employment outcome data, reporting and making policy recommendations, as well as strengthening data tools available to institutional and public users.

- Collaborates with institutional and agency partners to carry out the work
- Contributes to the agency's collaborative team culture, helps achieve the agency's strategic goals, and commits to continuous growth and learning.

The ideal candidate:

- o is passionate about public service and education
- o is a thought partner, a good communicator, intellectually curious, and a doer
- o is committed to continuous learning and growing
- o is a supportive colleague, reinforcing a strong team-focused culture

Education and Experience:

- Master's degree in economics, data analytics, public policy, business administration, or related
- Five years of higher education, education, government, or other related experience.
- Additional years of relevant experience may be substituted for the Master's degree.

- Commitment to public service and passion for education
- Ability to conceptualize and bring a project to fruition
- Demonstrated ability to work with a variety of stakeholders, such as college and university officials, state agency executives, and the business and employer community, among others.

- Data visualization, mapping, and related skills a plus.
- Strong interpersonal skills, with a commitment to collaboration and teamwork

Work location

Work locations are Chicago, IL, with a fully remote work schedule or Springfield, IL, with a hybrid schedule. Those located in other areas of Illinois will also be considered. Occasional travel within Illinois is expected, as required by the work.
